General

1. This Addendum No. 1 forms a part of the Bidding and Contract Documents and modifies the Plans and Specifications for the City of Pinole San Pablo Avenue Pavement Rehabilitation project released on September 29, 2021.
2. Proposers must acknowledge receipt of this addendum on Attachment 2 – Addenda Acknowledgement.
3. This Addendum No. 1 modifies the Bidding and Contract Documents in the following manner:
  - a. Modifies work hours to be between 7 am – 5 pm.
  - b. Replaces the subcontractor’s information fields with an updated table on the Designation of Subcontractors form (P-9).
  - c. Removes question # 13 on the Information Required of Bidder form.
  - d. Adds new attachment: Attachment 1 – Bidder’s Questionnaire
  - e. Adds a new attachment: Attachment 2 – Acknowledgement of Addendums

REVISIONS TO THE SPECIFICATIONS

- a) **WORKING HOURS**  
CHANGE TO READ

The Contractor shall forfeit, as penalty to the City, the sum of twenty-five (\$25.00) dollars for each worker employed in the execution of the contract by Contractor or by any subcontractor under him for each calendar day during which such worker is required or permitted to work more than forty (40) hours in any one calendar week, in violation of the provisions of Article 3, Chapter 1, Part 7, Division 1 of the Labor Code (Section 1810 et. seq.). Working hours shall be limited to **7:00 AM – 5 PM**.
